# **Complete Rules**

#### Eligibility

Any licensed general contractor, specialty contractor, or construction manager member of the Metro Washington or Virginia Chapters of ABC may enter. Subcontractors acting as the general contractor on the project entered are also eligible. Questions concerning eligibility should be directed to ABC Virginia 703-968-6205.

#### **Entry Fee**

A fee of \$399 is required with each entry in each category. You may pay by credit card after the form is completed.

#### **Number of Entries**

There is no limit to the number of entries per member or in any one category. A project may be entered in more than one category. Clearly specify and remit payment for each project in each category entered.

#### **Completion Dates**

Eligible projects must have been completed between January 1, 2021 and June 1, 2022 Judging teams reserve the right to disqualify projects that are deemed incomplete. Previously entered and judged projects are not eligible. Projects deemed incomplete are ineligible for a refund of the entry fee.

## Location

Projects submitted must be located in the District of Columbia; the Maryland counties of Anne Arundel, Calvert, Charles, Frederick, Howard, Montgomery and Prince George's; or the Virginia counties of Arlington, Fairfax, Fauquier, Loudoun, Prince William, Stafford and the cities within.

## Self-Performance

All trade categories entered must be self-performed by the company entering the project.

### Safety

- Fatality Part A: Any **company** that experienced a safety-related fatality of a direct employee in the United States within the current program year is not eligible for an EIC award.
- Fatality Part B: A company that experienced a safety-related fatality of an employee within two and three years of the current program year is required to provide additional information regarding action that has been taken following the fatality.
- OSHA Forms: Even if STEP certified, a company that does not provide project-specific OSHA Forms 300 and 300A (personal information redacted) OR company-specific forms for the year(s) the project was under construction is not eligible for an EIC award.
- Your company must sign the Construction Coalition for a Drug and Alcohol-Free Workplace pledge at <u>www.drugfreeconstruction.org</u>
- Safety and Health Policy Manual: A company that does not have a written safety and health policy manual is not eligible for an EIC award. (If an applying company participates in STEP, this information has been verified during the STEP application process, so the applicant can skip this question)

#### **Labor Requirements**

No project is eligible that was subject to a requirement that contractors enter into agreement(s) with any labor organization as a condition of performing work.

#### Deadline Entries must be received on or before Friday, April 22, 2022.

**Photography** Digital photo file(s) must accompany each entry. Acceptable formats are JPEG, PNG or Tiff in high resolution. Please submit no more than **3 photos per entry**. (Note that photos are not used in the judging process, but may be selected for promotional material).

Logo A digital file of your company's logo must be submitted with each entry.

**Publicity** All accepted entries become the property of Associated Builders and Contractors and may be used for publication or for any other purpose by the Metro Washington and Virginia chapters of the association.

Judging Requirements The Construction Awards Committee reserves the right to disqualify entries without a fully completed entry form, or to disqualify or re-categorize any entry, with cause and proper notification to the contractor.

# **Submission Requirements**

Before beginning this entry form, please make sure you have assembled the items below, as they will be required during the submission process. An **entry fee** of \$399 per entry is required. You are required to pay by credit card after the form is completed. A list of all subcontractors and service contractors who worked on the project.

• Please include full contact information along with a brief description of the type of work performed (e.g., landscaping, drywall, scaffolding, concrete and masonry, etc.).

• This list must be submitted along with your entry form (in Excel format) no later than April 22, 2022. ABC subcontractors will be recognized on all winning projects.

Security information - Please inform us if this project requires security information for the judging process on June 21, 2022. A brief description of the project. Be as detailed as possible as it will assist in the judging or promotion of your entry. Please limit your description to no more than 500 words. Digital photo file(s) must be uploaded for each entry. Acceptable formats are JPEG, PNG or Tiff in high resolution. A digital file with your company logo in JPEG, PNG or Tiff format is required and can be uploaded near the end of this form. Letter of reference - If submitting a project in the Excavation/Site Preparation category, you will need to submit a letter of reference since there will be no on-site judging. The entire entry form must be completed.
